  - e. A description of any relationship between you and any such child.
3. If within the past three years there have been any allegations against you of any sexual abuse of any child, please describe in detail each allegation of sexual abuse of any child, indicating as follows:
  - a. Any fondling,
  - b. Any kissing,
  - c. Any penetration with fingers,
  - d. Any sexual intercourse,
  - e. Any sodomy.
4. Within the past three years has there been any investigation of you by any governmental agency involving any allegations of sexual abuse of any child?
5. If your answer to the preceding interrogatory is in the affirmative, please describe any such investigation in detail, including the following:
  - a. The name of each such governmental agency investigating any allegation of sexual abuse of any child,
