

Property Distribution — Unmarried Cohabitants.

Definitions

As used in these interrogatories, the words "occurrence" or "alleged occurrence" shall mean the facts involved in the combined events and incidents which allegedly caused injury or damage to the plaintiff as a result of or as a consequence of the cohabitation of the parties as described in the plaintiff's complaint.

As used in these interrogatories, the words "cohabitation" and "cohabit" shall mean and refer to the living together of the plaintiff and the defendant.

 - g. Your custody of children, identify each child by name and age,
 - h. Your health status.

 - c. Whether you have had custody during cohabitation,
 - d. Each child's age when cohabitation began,
 - e. The dates when each child's cohabitation began,
